Public Spaces Protection Order (PSPO)

1 Purpose of Report

- 1.1 To provide an update in respect of the changes proposed to the Public Spaces Protection Order (PSPO), and request approval to consult on the restrictions in relation to the application for PSPOs under the Anti-Social Behaviour, Crime and Policing Act 2014 in Stafford Borough.

2 Proposal of Cabinet Member

- 2.1 That the report be noted and permission given to undertake consultation on the proposed Public Space Protection Orders (PSPO) in Stafford Borough (a further report to be submitted to Cabinet once the consultation has concluded and results analysed);
- 2.2 Approval be granted for the proposed use of CCTV for the issuing of Fixed Penalty Notices for breaches, as set out in the report.

3 Key Issues and Reasons for Recommendation

- 3.1 The existing PSPOs expire on 6 December 2023. This proposal aims to replace the existing town centre PSPOs (extending the geographical areas and the restricted behaviours covered, based on need), and renew the existing PSPOs around dog restrictions (extending them for a further 3 years).
- 3.2 PSPO's can only be granted for a maximum of 3 years and consultation must be carried out prior to renewal. The existing order has been successful and has reduced the complaints received on matters covered in the order. As the

existing PSPO has been successful, we wish to extend it, to cover further issues on which we have received complaints to deal with these issues and make the town centres and open spaces safer and more attractive places to visit.

- 3.3 To date over 80 Fixed Penalty Notices (FPNs) have been issued for breaches of the current PSPO.
- 3.4 Given the ambitious plans for the town centre, and the desire to increase footfall it is important that anti-social behaviour doesn't undermine the investment and have a detrimental effect on the town.

4 Relationship to Corporate Business Objectives

- 4.1 This contributes to all the corporate business objectives and directly supports business objective 2: 'To improve the quality of life of local people by providing a safe, clean, attractive place to live and work and encouraging people to be engaged in developing strong communities that promote health and wellbeing'.

5 Report Detail

- 5.1 PSPO's are intended to deal with a particular nuisance or problem in a particular area that is detrimental to the local community's quality of life, by imposing conditions on the use of that area which apply to everyone. A PSPO can make requirements, prohibitions, or both within a specified area. They can also be used to restrict access to specific areas to address ASB, however if this was required, consideration would need to be made in terms of the impact of such a restriction and if there are any alternatives. There are currently no proposed areas where access should be restricted.

Updated Statutory guidance issued in March 2023 on the Anti-Social Behaviour, Crime and Policing Act 2014, further stresses the need for local authorities to utilise all their tools and powers and promote greater consistency in their use, and to coincide with the launch of the ASB action plan.

It is proposed that the Council enhances the current PSPOs (**APPENDIX 1**) for both Stafford and Stone Town Centres in terms of geographical locations and the restrictions contained within them. The new PSPO proposal contains provision for additional restrictions including busking and the use of amplifiers, feeding birds in the town centres and other open spaces across the borough, as well as restricting the use of BBQ's or equivalent on public land. These proposals are as a direct result of complaints received by the council and partners. The statutory consultation will clarify whether these restrictions are supported by residents, businesses, and partners. The existing restrictions also need to be extended to cover all the destination parks across the borough. Additional draft restrictions are contained in **APPENDIX 2**. New

restrictions are based on issues reported to the council and partners over the 3 years since the last order was approved.

Many businesses within the town centres have identified certain behaviours having a negative impact on their trade and support enforcement action being taken to address such behaviour. For example, most of the complaints in Stafford town centre regarding busking have come from the businesses. Businesses in Stone High Street have also complained that vehicles driving through the pedestrianised zone have a direct negative impact on them.

The existing order has been successful and has reduced the complaints received on behaviour already covered. The new proposed restrictions will enable us to address the complaints we have been receiving.

To date over 80 FPN's have been issued for breaches of the current PSPO.

- 5.2 These new proposed areas and restrictions would be in addition to the existing restrictions contained in the existing order, restrictions on motor vehicles, bikes, scooters, skateboards/ roller skates, groups of 5 or more loitering and likely to cause anti-social behaviour/ intimidation, tents, and organisations canvassing for bank details or sale of services by direct debit or face to face fund raisers. Also, dog exclusions, dog fouling and dog control for a further 3-year period.
- 5.3 The maximum duration of a PSPO is three years but they can last for shorter periods of time where appropriate and at any point before expiry, the Local Authority can extend or vary a PSPO by up to three years if they consider that it is necessary to prevent the original behaviour from occurring or recurring or if there is a need to alter/remove an existing prohibition or requirement, or to introduce a new one. The validity of a PSPO may be challenged by way of application to the High Court within six weeks of the order being made. Only those who are directly affected by the restrictions (i.e., persons who live in the restricted area or work or live there) can challenge the PSPO. Failure to comply with a prohibition or requirement as stated within the order is a criminal offence. Enforcement officers within the Local Authority and Police can issue a fixed penalty notice of up to £100 for breaches of an order if appropriate. A fine of up to (£1000 can be imposed upon conviction in the Magistrates' Court.
- 5.4 Only local authorities can apply for a Public Spaces Protection Order, but enforcement powers are much broader. The test is designed to be broad and focus on the impact the anti-social behaviour is having on victims and communities. A PSPO can be made by the council if they are satisfied on reasonable grounds that the activities carried out or likely to be carried out, in a public space: -

- have had, or are likely to have, a detrimental effect on the quality of life of those in the locality;
- is, or is likely to be, persistent and continuing in nature;
- is, or is likely to be unreasonable;
- justifies the restrictions imposed.

To meet the test requirements, evidence is necessary to justify the restrictions imposed. Meetings have already taken place with internal and external stakeholders to discuss the new proposed restrictions. These new restrictions have come from repeat complaints that the council and police have received, which the public continue to report. Formal consultation with the public of Stafford and stakeholders will then be undertaken, as is required by the legislation. A copy of this consultation questionnaire is attached as **APPENDIX 3**.

- 5.5 If the order is authorised a copy of the order must be published, and signs displayed in key areas to show members of the public that a PSPO is in place and what the restrictions are.
- 5.6 It's proposed that all breaches of the PSPO are continued to be dealt with by means of issuing a Fine via a Fixed Penalty Notice (FPN) at a level of £100 reduced to £75 if paid within 10 days.
- 5.7 FPN's can be served on a juvenile as well as an over 18. It is proposed that we set the lower age limit at 14 years. However, if there are exceptional cases where the perpetrator is between 10 and 14 and is causing significant issues breaching the PSPO, Community Safety Officers would discuss the matter with Legal colleagues on a case-by-case basis before issuing a FPN. There is no stipulation in the legislation on the lower age that a FPN can be served. However, children over the age of 10 can be charged and taken to court with criminal offences. Research shows that other authorities which have PSPO's use the over 10's age limit for issuing FPN's however they state it is at their discretion.
- 5.8 In addition to assist in the process of identifying vehicles that breach the PSPO by driving through the pedestrians' areas of Stafford and Stone (covered by the PSPO) CCTV will be utilised. Working with the DVLA, fines can issued directly to the registered keepers.

6 Implications

6.1 Financial

Existing resources will be utilised. Partnership Officers, Enforcement Officers (Licensing and Environmental Crime) will assist with consultation and details of the proposed order. Staffordshire Police have committed to working in partnership to are likely to be required to assist in the enforcement of the town

centre PSPOs. Enforcement Officers (Licensing and Environmental Crime) will enforce the dog control restrictions.

There will be some additional costs in terms of new larger signage and any advertising via local media.

6.2 Legal

The purpose of this report is to seek approval to undertake the formal consultation required for the council to establish that the proposals to renew and replace the existing PSPOs meet the statutory test set out in 5.4 above. The Legal service has been and will continue to be consulted with for advice around enforcement options and the wording of the order. At this stage, there are no wider legal implications.

The Anti-Social Behaviour Crime and Policing Act 2014 is designed to put victims at the heart of an organisation's response to ASB and gives professionals the flexibility to deal with any given situation.

STAFFORD BOROUGH COUNCIL
ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014
THE BOROUGH OF STAFFORD
PUBLIC SPACES PROTECTION ORDER 2020

The Stafford Borough Council ("the Council"), in exercise of its powers under Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act"), hereby makes the following Order:-

1. This Order shall come into operation on the 7th day of December 2020 and shall have effect for a period of three years from the date thereof (unless it is extended pursuant to Section 60 of the Act).
2. This Order applies to the areas within the Borough of Stafford as specified in the Schedule to this Order and shown marked on the attached plans at Appendices 1 and 2, being public spaces in the Council's area to which the Act applies ("the Restricted Areas").

BY THIS ORDER

3. The effect of this Order is to impose the following prohibitions and/or requirements in the Restricted Areas at all times:-

(a) Alcohol

- Any person is prohibited from having an open alcohol container in his/her possession;
- Any person is required to surrender any open alcohol container in his/her possession when required to do so by an Authorised Officer of the Council.

(b) Dog Fouling

- Any person is required to remove the faeces of a dog he/she is in control of, immediately after the dog has defecated;

(c) Dogs on Leads

- Any person who is in control of a dog in a "no dogs off lead" restricted area is required to keep the dog on a lead at all times, and such lead must not exceed a length of two metres.

(d) Dogs on Leads by Direction

- Any person who is in control of a dog is required to put and keep the dog on a lead, if given a direction to do so by an Authorised Officer of the Council.

(e) Dog Exclusion Areas

- Any person is prohibited from allowing a dog he/she is in control of to enter the designated play areas as specified in the Schedule to this Order and indicated in the attached plans at Appendix 2.

(f) Dog Walking

- Any person is prohibited from walking more than 4 dogs at any one time.

(g) Motor Vehicles

- All motor vehicles are prohibited from travelling or parking along the pedestrianised areas of Stafford and Stone town centres (as indicated in the attached plans at Appendix 1), save for those vehicles that are exempt by virtue of paragraph 4(iv) of this Order.

(h) Bicycles, Scooters, Skateboards and Roller Skates

- Any person is prohibited from riding on a bicycle, scooter, skateboard or roller skates (including roller blades) along the pedestrianised areas of Stafford and Stone town centres (as indicated on the attached plans at Appendix 1).

(i) Loitering

- Any person is prohibited from loitering or otherwise gathering in groups of five or more within the pedestrianised areas of Stafford and Stone town centres (as indicated on the attached plans at Appendix 1).

(j) Tents

- Any person is prohibited from erecting, sleeping in, or otherwise being in a tent (or like structure) within the pedestrianised areas of Stafford and Stone town centres (as indicated on the attached plans at Appendix 1).

(k) Canvassing

- Any person is prohibited from canvassing for the sale of services by means of direct debit, or for the purpose of obtaining an individual's bank account details, or for the purpose of face-to-face fund raising, within the pedestrianised areas of Stafford and Stone town centres (as indicated on the attached plans at Appendix 1).

(For the purposes of 3 (b), (c), (d), (e) and (f) above, a person who habitually has a dog in his/her possession shall be taken to be in control of the dog at any particular time, unless at that time some other person is in control of the dog).

4. Exemptions

- (i) Nothing in Paragraph 3(a) of this Order shall apply to a person who is in possession of an open alcohol container within the curtilage of any licensed premises located within a restricted area, or any premises licensed under s.11 of the Licensing Act 2003 for the supply of alcohol or premises permitting the sale of alcohol by s.100 of said Act (Temporary Event Notice), or by s.115E of the Highways Act 1980.
 - (ii) Nothing in Paragraph 3(b) to 3(f) of this Order shall apply to a person with a disability who is accompanied by an assistance dog. A person with a disability is defined under s.6(1) Equality Act 2010 (as amended) as a person with -
 - (a) A physical or mental impairment, and
 - (b) The impairment has a substantial and long-term adverse effect on his/her ability to carry out normal day-to-day activities.
 - (iii) An assistance dog is defined under s.173(1) of the Equality Act 2010 (as amended) as –
 - (a) A dog which has been trained to guide a blind person;
 - (b) A dog which has been trained to assist a deaf person;
 - (c) A dog which has been trained by a prescribed charity to assist a disabled person who has a disability that consists of epilepsy or otherwise affects his/her mobility, manual dexterity, physical co-ordination or ability to lift, carry or otherwise move everyday objects; or
 - (d) A dog of a prescribed category which has been trained to assist a disabled person who has a disability (other than one falling within paragraph (c) of a prescribed kind).
 - (iv) Nothing in Paragraph 3(g) of this Order shall apply to emergency, cash-in-transit or Royal Mail vehicles, or to vehicles of any kind being used solely for the purposes of loading and unloading on any day between the hours of 4:00pm and 10:00am only.
5. An "Authorised Officer of the Council" means an employee of Stafford Borough Council, a Police Officer or Police Community Support Officer, or any other person who is authorised in writing by the Council for the purposes of giving directions under this Order.
6. The Council is satisfied that the conditions set out in Sections 59, 64 and 72 of the Act have been satisfied, and that it is in all the circumstances expedient to make this Order for the purposes of reducing anti-social behaviour in the restricted areas. The Council makes the Order because anti-social behaviour in the restricted areas has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent or continuing nature such as to make it unreasonable, and justifies the restrictions imposed in this Order.

7. Offences

- i. It is an offence for any person, without reasonable excuse, to engage in any activity which is prohibited by this Order.
- ii. A person commits an offence if he fails to give his name and address when required to do so by an Authorised Officer of the Council, or gives a false or inaccurate name or address when an Authorised Officer proposes to give a person a Fixed Penalty Notice for engaging in any activity which is prohibited by this Order.
- iii. Any person who is found to be in breach of any provisions of this Order shall be liable on summary conviction to a maximum penalty of Level 3 on the Standard Scale, or if in receipt of a Fixed Penalty Notice, to a financial penalty of up to £100.00.

8. Revocation

This Order hereby revokes the Borough of Stafford Public Spaces Protection Order 2017 made on 30th November 2017.
