CAB106 Minutes

Minutes of the meeting held on 11 June 2020 were agreed as a correct record.

CAB107 Covid-19 Pandemic Recovery Planning

Considered a report setting out the Council's proposed approach to recovery from the response to the COVID-19 pandemic and seeking agreement that the existing business objectives of the Council (as set out in Corporate Business Plan 2018-2021) be reviewed in light of the consequences of COVID-19.

The Leader of the Council reiterated the 3 business objectives of the Council before detailing the 3 proposed recovery phases as set out in paragraph 5.7 of the report. Councillor Farrington continued by noting the recovery work streams and their associated terms of reference and membership.

The Cabinet confirmed that they welcomed the report, praising its detailed content and emphasis on working with partner organisations and allowing the opportunity to review the Councils major strategies and projects.

Councillor Farrington addressed a number of queries raised by Councillor A T A Godfrey and confirmed that all Members of the Council would have the opportunity to contribute to the recovery process through the Scrutiny Committees.

The Leader of the Council concluded the debate by highlighting the proposals as set out in paragraph 2 of the report, to which the Cabinet voted on the recommendations.

CAB108 Doxey Parish Neighbourhood Area Application

Considered a report seeking approval to designate Doxey Parish as a Neighbourhood Area for the purpose of producing a Neighbourhood Plan within the remit of the Town and Country Planning Act 1990 (as amended by the Localism Act 2011) and further following such designation, to publish details of the same.

The Deputy Leader of the Council reported on his experiences in dealing with the preparation of the High Offley Local Plan.
