CAB4 Minutes

Minutes of the meeting held on 29 May 2025 as published on 30 May 2025 were agreed as a correct record.

CAB5 Apologies

Apologies for absence were received from Councillors I D Fordham and G P K Pardesi.

CAB6 VfM Progress Report - Quarter 4/End of Year Report for 2024/25

Considered a report advising Members on the progress in the delivery of the VFM Improvement Plan at the end of Quarter 4 2024/25.

The Cabinet Member, Resources Portfolio, introduced the report noting the detail as set out in paragraphs 1 to 5 before concluding his comments by recommending that the proposals as set out in paragraph 2 be approved.

Councillor Cooke was pleased to report the publication of the statement of accounts for 2023/24 which represented a key achievement in this area of work.

CAB9 Proposals for an increase in Fares: Hackney Carriage Vehicles

Considered a report enabling Cabinet to consider a request from Stafford Taxi Rank Association, on behalf of the Borough's Hackney Carriage Proprietors, for an increase in fares.

The Deputy Leader, on behalf of the Cabinet Member, Environment Portfolio introduced the report noting the detail as set out in paragraph 1 and the associated appendices before concluding his comments by recommending that the proposals as set out in paragraph 2 be approved.

The Cabinet subsequently voted on the recommendation, which was declared to be carried.

RESOLVED:- that the proposals of the Cabinet Member, Environment Portfolio be approved as follows:

That:-

(a) the revised table of fares set out in appendix 1 of the report for Hackney Carriages licensed by the Council be approved for consultation purposes;

(b) the revised charges be advertised in accordance with the Local Government (Miscellaneous Provisions) Act 1976;

(c) the revised charges be implemented as soon as possible, subject to any objections arising.

CAB10 Taxi Licensing Policy and Licence Conditions 2025 - 2030

Received a report considering an amended Taxi Licensing Policy and Licence Conditions 2025 ("the Policy") which set out the Council's approach to regulating the Hackney and Private Hire Vehicle trade under the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976 as amended. The Policy had been updated and revised to incorporate provisions made to steer the trade towards carbon neutrality, new guidance on the determining the suitability of applicants and licensees in the hackney carriage and private hire industry and proposing an incentive to increase the number of Hackney Carriage Licensed by the Borough.

The Deputy Leader, on behalf of the Cabinet Member, Environment Portfolio introduced the report noting the detail as set out in paragraphs 1 and 3 and the associated appendices before concluding his comments by recommending that the proposals as set out in paragraph 2 be approved.

Councillor A N Pearce was pleased to note the detail of appendix 11 of the Policy relating to idling vehicles.

The Cabinet subsequently voted on the recommendation, which was declared to be carried.

RESOLVED:- that the proposals of the Cabinet Member, Environment Portfolio be approved as follows:

That Council be recommended to:

- (a) approve and publish the revised 2025 Policy and Conditions, subject to minute (d) below;
- (b) authorise the Head of Regulatory Services to make any amendments to the Policy required due to changes in legislation or government guidance and minor variations to the Policy in the interests of operational efficiency;
- (c) authorise the Head of Regulatory Services, subject to broad headline dates being agreed by Council, and any external factors beyond the Council's control, to determine the dates/timescales within the revised Policy relating to vehicle emissions, the phasing out of licensed vehicles powered only by internal combustion engines and the introduction of electric and hybrid vehicles into the licensed taxi and private hire fleet.
- (d) approve or reject each of the three proposals from the Trade detailed in Paragraph 5.5 of the report and instruct the Head of Regulatory Services to update and implement the Policy accordingly.

CAB12 Stafford Town Centre Regeneration Capital Programme Change -Confidential

Considered a confidential report recommending approval to amend the capital programme to reflect the leasehold purchase of a town centre site as part of the Stafford Town Centre Transformation Programme.

The Deputy Leader introduced the report noting the detail as set out in paragraph 1 before recommending that the proposals as set out in paragraph 2 be approved.

The Cabinet subsequently voted on the recommendation, which was declared to be carried.

RESOLVED:- that the proposal of the Deputy Leader be approved as follows:

That:-

- (a) it be recommended to Council that the capital programme be updated to include £332,000 in respect of the leasehold acquisition of the site as identified on the plan in appendix 1 of the confidential report, funded by the Council's reserves;
- (b) a revenue budget be established from reserves to support the associated activities £88,000 as identified in paragraph 5.15 of the confidential report;
- (c) authority be delegated to the Head of Economic Development and Planning (in consultation with the Deputy Leader, the Cabinet Member for Economic Development and Planning and the Council Section 151 Officer) to take all necessary steps to complete the acquisition set out in minutes (a) and (b) above;
- (d) authority be delegated to the Head of Economic Development and Planning (in consultation with the Deputy Leader, the Cabinet Member for Economic Development and Planning, the Council Section 151 Officer and the Stafford Town Centre Transformation Programme Board) to progress the delivery plan of the acquired site. This will include appointment of external contractors, preparation and submission of regulatory approval applications, conducting relevant surveys and entering into any necessary license agreements to deliver the programme as a whole.

CAB13 Land Acquisition - Stafford Station Gateway - Confidential

Considered a confidential report updating Cabinet on progress made in relation to the Stafford Station Gateway project, following the receipt of a Memorandum of Understanding (MoU) relating to the award of funding from the Levelling Up Fund (LUF).

The Cabinet Member, Economic Development and Planning Portfolio, introduced the report noting the detail as set out in paragraphs before recommending that the proposals as set out in paragraph 2 be approved.

The Cabinet subsequently voted on the recommendation, which was declared to be carried.

RESOLVED:- that the proposal of the Cabinet Member, Economic Development and Planning Portfolio be approved as follows:

That:-

- (a) the update provided in relation to the LUF allocation be noted;
- (b) it be recommend to Council that the capital programme be amended to reflect an overall cost of £3.735m to complete the acquisition of the land identified within the red line boundary set out within confidential appendix 1 of the report, subject to the conditions as set out in paragraph 5.20;
- (c) authority be delegated to the Head of Economic Development and Planning (in consultation with the Deputy Leader, the Cabinet Member for Economic Development and Planning and the Council Section 151 Officer)to take all necessary steps to complete the acquisition of the site;
- (d) a revenue budget of £90,000 be established to support the associated activities as identified in paragraph 5.21 of the report.
