<p>Contracts</p> <p>(Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority -</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharge.)</p>		
<p>Land</p> <p>(Any beneficial interest land which is within the area of the relevant authority)</p>

<p>Licences</p> <p>(Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.</p>		
<p>Corporate tenancies</p> <p>(Any tenancy where to your knowledge) -</p> <p>(a) the landlord is the relevant authority; and</p> <p>(b) the tenant is a body in which the relevant person has a beneficial interest.</p>

<p>Securities</p> <p>(Any beneficial interest in securities of a body where -</p> <p>(a) that body where to your knowledge has a place of business or land in the area of the relevant authority; and</p> <p>(b) either -</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>
