# CAB68 STONEFIELD PARK - LEISURE FACILITIES

Further to Minute No CAB44/09 of the Cabinet of 3 December 2009, the decision of the Cabinet had been subsequently called in to the Leisure Scrutiny Committee on 15 December 2009.

The Leisure Scrutiny Committee had decided that the matter be referred back to the Cabinet for further consideration in order to allow a meeting between the Cabinet Member and representatives of the Action Group and other interested parties to take place.

RESOLVED:- that the decision of the Cabinet, as contained in Minute No CAB44/09, be reaffirmed as follows:-

### That:- (i) (a) Section 106 funding be allocated to allow the existing grass tennis courts to be resurfaced to provide

an all year round facility, suitable for all playing abilities, with an appropriate fencing scheme;

- (b) Section 106 funding be allocated to enable one gate to be fitted with a magnetic lock enabling the site to be unlocked automatically;
- (ii) the undertaking of the Cabinet Member, Leisure, that any other permitted activity on the Courts would be supervised by a competent person, be noted.
