#### CAB08 PROPOSED SUSTAINABLE COMMUNITY STRATEGY

Considered the draft Sustainable Community Strategy for Stafford Borough for consultation purposes, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Leader of the Council be approved as follows:-

That the proposed Sustainable Community Strategy for Stafford Borough be approved for consultation purposes.

### CAB09 STAFFORD BOROUGH LOCAL DEVELOPMENT FRAMEWORK -EVIDENCE-BASE STRATEGIC HOUSING LAND AVAILABILITY ASSESSMENT (SHLAA)

Considered a report relating to the Stafford Borough Local Development Framework - Evidence-Base Strategic Housing Land Availability Assessment (SHLAA) as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Cabinet Member - Planning and Regeneration be approved as follows:-

# That (a) the Stafford Borough Housing Land Partnership be established and progresses

with the Strategic Housing Land Availability Assessment's initial findings to inform work preparing the new Stafford Borough Local Development Framework;

(b) the Cabinet place on record its appreciation of the work undertaken by the Officers in the preparation of the report.

### CAB10 STAFFORD BOROUGH LOCAL DEVELOPMENT FRAMEWORK -PRINCIPLES FOR SETTLEMENT DEVELOPMENT

Considered a report relating to the Stafford Borough Local Development Framework - Principles for Settlement Development, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Cabinet Member - Planning and Regeneration be approved as follows:-

That:-

- (a) the principle of categorising and identifying the potential for future development at settlements outside of Stafford and Stone within Stafford Borough through the application of a systematic approach be approved;
- (b) the suggested methodology for establishing the settlements to provide for future development be approved;
- (c) public consultation on (a) and (b) above be approved.

## CAB11 RIVERSIDE CAR PARK ORDER

Considered a report relating to amending the current car parking order regulating the use of the Riverside Car Park, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Cabinet Member - Planning and Regeneration be approved as follows:-

That the Head of Planning and Engineering, in conjunction with the Head of Law and Administration, be authorised to take all necessary steps to amend the current Riverside Car Park Order to make it available as a long stay car park.

### CAB12 OPTIONS AVAILABLE FOR THE COLLECTION OF CARDBOARD WASTE

Considered alternative options for the recycling, composting or disposal of cardboard in the domestic waste stream, in response to intervention by the Environment Agency, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Cabinet Member - Environment be approved as follows:-

That the Council proceed with the preferred Option (b) which, following a comprehensive publicity campaign offering practical guidance and support to the public, will require householders to put waste cardboard in the blue bin for recycling.

#### CAB13 FARE CHARGES FOR HACKNEY CARRIAGES LICENSED BY STAFFORD BOROUGH COUNCIL

Considered a review of the fares imposed by this Council upon all hackney carriages licensed by the Council, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

- RESOLVED:- that the proposal of the Cabinet Member Environment be approved as follows:-
  - That:- (a) the revised scale of charges set out under Option 1 in APPENDIX 1 for hackney carriages licensed by the Council be approved;
    - (b) the revised charges be advertised in accordance with the Local Government (Miscellaneous Provisions) Act 1976;
    - (c) the revised charges be implemented as soon as possible, subject to any objections arising.

## CAB14 IMPROVEMENTS TO FACILITIES - ROWLEY PARK SPORTS STADIUM

Considered a report relating to proposed improvement to facilities at the Rowley Park Sports Stadium, as set out in Section 2 of Digest No 116 issued on 13 June 2008.

RESOLVED:- that the proposal of the Cabinet Member - Leisure be approved as follows:-

That:-

- (a) the Section 106 Agreement contribution relating to the development at Tesco, Newport Road, Stafford (Ref. No. 40654), of £332,000 (£307,000 plus interest) be allocated to the improvement of facilities at Rowley Park;
- (b) a sum of £30,000 be allocated in the Capital Programme 2008/09, from an amount of £332,000 already received by the Council, to undertake a design specification related to the above proposal to include for:-
  - an extensive land survey including land ownership, drainage and constraint issues across the site;
  - preliminary design drawings to cover the extent of how car parking can be improved to minimise closure and support increased use, improved changing accommodation and improved spectator area to include seats and a covered spectator area;
  - a full budget estimate;
  - an assessment of the construction period and phasing of works and the various options for consideration
  - pre planning application consultations;
  - ecology and biodiversity assessments;
  - cost assessment to include for project management, detailed feasibility, design and supervision and all fees;
  - planning application submission;
- (c) £10,000 be allocated from the £332,000 funding received under the Section 106 Agreement to replace the dilapidated boundary fencing around areas of the site to improve security and to reduce vandalism.

### CAB15 SAFEGUARDING AND PROMOTING THE WELFARE OF CHILDREN AND YOUNG PEOPLE
