#### RESIDENTS AND GOVERNMENT ASKED FOR HOME HELP

A public consultation is taking place early next year for residents and businesses across Stafford Borough to give their input about future development in the area over the next 20 years.

The West Midlands Regional Spatial Strategy sets out the planning policies for the region covering housing and economic development, waste and transport. It requires the borough to provide 10,300 new homes by 2026, as well as 50,000 sq m of retail floorspace and 45,000 sq m of office floorspace over the next 20 years and 120 hectares of employment land by 2021.

Doug Davis, Cabinet Member for Planning and Regeneration, said for the council to deliver proposed developments on this scale they would need the Government to provide the financial assistance to help the council investigate how the area can cope with growth of this magnitude.

"We are making it clear that to accommodate this number of new homes and other developments it must be accompanied by significant infrastructure investment – that is investment for roads, schools and health facilities," Cllr Davis added.

Stafford Town has been identified by the Regional Spatial Strategy as a "settlement of significant development" – so at least 7,000 of the total new homes must be found in and around Stafford Town.

Members of the public and businesses in the borough are being asked to watch out for details in January of the public consultation to ensure they have a say on these significant proposals.

# WHERE WILL 10,300 NEW HOMES GO? You help us decide

EXCLUSIVE by Stafford Borough Council

More than 10,000 new homes need to be built in the area over the next 20 years. But where will they go?

The council is asking residents and businesses across the Borough to play their part in shaping the future of the area. This work will guide preparation of the new Development Plan for our area called the Stafford Borough Local Development Framework - which will replace the Stafford Borough Local Plan and guide decisions on planning applications

Recently Stafford Borough Council has been presented with new development figures to be provided in the area regional plan called the West Midland's Regional Spatial Strategy.

For the period 2006 – 2026 the

For the period 2006 – 2026 the following new development needs to be built in the area. Although these figures, particularly for housing, could increase:

- 10,300 new homes in Stafford Borough of which 7,000 new houses to be in the County Town of Stafford
- 120 hectares of new employment land with a continuous five year supply being available of 40 hectares
- 30,000 square metres of new retail space by 2021 with a further 20,000 square metres beyond 2021, the majority being in Stafford
- 40,000 square metres of new offices in Stafford

This level of new development is substantial for the Stafford Borough area. In terms of the scale of development 10,300 new houses is considerably more than the number of homes in the market town of Stone. Furthermore as an example there are 400 houses on the Castlefields estate near Stafford Castle. Therefore more than this number of new homes needs to be built every year in the Borough until 2026.

The West Midlands Regional Plan has identified 7000 of the new homes will be in Stafford which could mean over 3,000

to be built across the rest of the Borough. Reference is also made to cross border issues with the suggestion that land in South Staffordshire District should be considered to provide for the requirements of Stafford town.

Last year 450 new houses were completed and planning permission exists for over 3,270 new homes across the Borough of which approximately 1,600 are in Stafford, 550 are in Stone and 1,120 are in the rural areas. The Council is currently completing a piece of evidence called the Strategic Housing Land Availability Assessment which identifies further areas of land within existing residential areas where new houses might be built in the future. New housing with planning permission built in existing areas will reduce the amount of Greenfield sites required.

Cabinet Member for Planning and

Cabinet Member for Planning and Regeneration, Councillor Doug Davis, said: "Stafford Borough is facing a period of unprecedented change in terms of what our towns, villages and countryside will look like in years to come.

"All areas are subject to change so it is important to consider what types of changes should be taking place. And this consultation is a chance to tell us of any opportunities or issues that are important for the area you live or work in."



#### YOUR BOROUGH

Head of Policy and Improvement at Stafford Borough Council, Norman Jones, said it was a great opportunity for residents to help the Council shape services for the future.

"We need local people who care about

their area to give an input prior to key decisions being made which can affect the lives of around 120,000 residents in this Borough."

Letters are going out to householders in the area and roadshows will be set up in Stafford and Stone to encourage people to come on board.

#### COUNCIL ASKS FOR HOUSING HELP

More help is needed from the Government if major development is to go ahead in Stafford.

Thousands of new homes as well as offices and retail outlets will be coming to the area over the next 20 years. The requirement to undertake this major development was set out by the West Midlands Regional Spatial Strategy which sets out planning policy for the region.

But a senior Stafford Borough Councillor said the area would need financial assistance to help deliver developments on this scale.

Councillor Doug Davis, said: "We are making it clear that to accommodate this number of new homes and other developments it must be accompanied by significant infrastructure investment - that is investment for roads, schools and health facilities.

"The Government must provide the financial assistance to help the council cope with growth of this magnitude."

#### Council's Budget Balanced

Councillors in February will be asked to approve a below inflation increase of 3.9% in its Council Tax for 2008/09.

Work began on the Budget a year ago and has delivered a sustainable balanced budget which relies only on income from Government Grant, Council Taxpayers and service users. The Budget totals £17m for 2008/09 and as part of balancing the Budget the Council has found over £2m of savings and increased income, including £0.5m of efficiencies in back office services.



# MAP OF STAFFORD BOROUGH


