

**THE STAFFORD BOROUGH COUNCIL (257 TIXALL ROAD, STAFFORD)
COMPULSORY PURCHASE ORDER 2021**

**THE HOUSING ACT 1985 (AS AMENDED) AND THE ACQUISITION OF LAND
ACT 1981**


Stafford Borough Council of Civic Centre, Riverside, Stafford, Staffordshire ST16 3AQ (in this order called the acquiring authority) makes the following order:

1. Subject to the provisions of this order the acquiring authority is under section 17(1)(b) of the Housing Act 1985 (as amended) hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of the provision of housing accommodation.

2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown edged red and shaded pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in the Stafford Borough Council (257 Tixall Road, Stafford) Compulsory Purchase Order 2021" (the Order Map).
